Course Description: Focus and Purpose

Using a combination of lecture and seminar-discussion format, we will explore the basic concepts of management, organization, and their application to business operations. Mondays will consist of lecture and class discussion. Wednesdays will consist of class discussion about practical application of material, case studies, reflection exercises, and real world examples.

As an honors course, we will focus on both learning and development. The class format and structure encourages a deeper level of learning and thinking about management issues. Learning will go beyond simple memorization and identification of key management concepts and will encourage students to consider managerial implications and real world application – both good and bad. Students will be asked to consider their own opinions, preferences, and ideas behind important management decisions. The reflection and discussion format will help students develop their professional skills through both written and oral communication by providing students with the opportunity to become conversant in these issues.

As a result of this course, you should:

- 1. Describe and illustrate the four major management functions: planning, organizing, leading, and controlling.
- 2. Demonstrate decision-making and teamwork.
- 3. Identify any major developments in management thought.
- 4. Recognize social-responsibility initiatives.
- 5. Describe the nature of business strategy.
- 6. Demonstrate the use of operating plans, policies, procedures, and rules.
- 7. Analyze global business and how diversity impacts operations.
- 8. Develop a set of skills in oral and written discussion of both sides of management issues.
- 9. Develop a deeper understanding of your own competencies, values, beliefs, and interests as they relate to management, career options, and environments in the work world.
- 10. Demonstrate the ability to lead a small group discussion consisting of varying ideas.

Assignments and Course Requirements

Class Readings & Content: I will assign readings from our textbook, articles, case studies, videos, and/or podcasts on a weekly basis. Your role as a class member is to read, watch, or listen to the assigned material before coming to class. You should be prepared to discuss the content. I will usually ask you to bring to class a one-page journal entry (reaction paper) in which you record your thoughts about the readings. You will use the journal entries as a basis for our in-class discussions (see journal entries below).

Journal Entries: In order for you to get the most out of your course readings and content, you will regularly record journal entries. In these entries you <u>do not summarize</u> the material. Instead, you will relate the material to your personal experiences and/or what you have learned in other courses or in the media. I hope you will put some thought into your writing, but the content of your journal entries is up to you.

I will regularly (e.g., most Wednesdays) ask you to produce and submit to Canvas a typed (double-spaced) one-page journal entry based upon the course reading for that day. Your journal entry should consist of your reactions or thoughts about the reading just as if you were journaling about it. You should also bring a copy (electronic or hardcopy) with you to class. **Note**: Journal entries are due before our class session (12:30pm).

I will read all of your journal entries but will not evaluate their specific content. Rather, your entries will be evaluated based on how much thought was demonstrated. These entries should reflect some thought on your part and should be reasonably free of spelling, punctuation, and grammatical errors. In giving you credit for each journal entry I will use a *grading scale* posted on our Canvas course site.

Written Assignments - Case Studies: I will also give you three (short) writing assignments throughout the semester. These assignments will consist of an analysis of a case study related to our recent learning, discussions, and reading in the text.

All documents should be formatted in 12-point Times New Roman font, double-spaced with 1-inch margins. Points will be taken off for not following these standards. Case Study writing assignments are due on the assigned Friday by 4:59:59 pm (CT). More detailed information is posted on Canvas.

Weekly Quizzes: All quizzes are required to be completed each Friday by 4:59:59 pm (CT), and late quizzes are **NOT** accepted. Quizzes are open book/note and reflect all material included in the course (text, articles, discussions, videos, podcasts, etc.) and are due Friday by 4:59:59 pm (CT). You have 10 minutes to complete each quiz. You may not collaborate with anyone. Complete your work individually. Your electronic signature (i.e., accessing and submitting the quiz through Canvas) indicates that you completed this quiz on your own and without assistance. Each quiz is open for one week.

Exams: Two exams worth 100 points each will be given this semester. Exams will consist of multiple choice and short answer questions. Study guides will be provided before each exam.

Class Participation: Your participation and attendance are important for 1) the success of this class and 2) your success in the class. Class participation includes attendance, participation in class discussion, and your turn as discussion leader. If you are absent for more than 1 or 2 classes, it will affect your course grade (part of class participation). Points for missing class will be deducted from your class participation points.

Each student will sign up to be discussion leader one time during the semester. More information will be provided in class and on Canvas.

<u>Late Work Policy</u>: Late homework/quizzes/papers/exams are <u>NOT</u> accepted. If you have circumstances (death in the family, medical emergency) that affect your ability to complete the homework, please contact your me in advance of the due date. Late homework is not accepted. Make sure to test the technology and make the submission before the deadline. Also, ensure you have uploaded the CORRECT assignment. If you have mistakenly uploaded the wrong assignment, you are unable to submit the correct assignment after the due date. Always check your submission is the right assignment and it uploaded successfully.
